

IMAM RIDHA (A.S) HARDSHIP FUND

Secretariat Initiative

OVERVIEW

The Imam Ridha (a.s) Hardship Fund (IHRF) was set up to support individuals and families in our community who are going through difficult times. Life can bring unexpected challenges — sudden job loss, illness, rising living costs — and this Fund is a safety net to ensure that no one is left without the essentials they need.

Through the generous Sadaqah donations of community members, the Fund provides assistance towards food, groceries, utility bills, clothing, nappies, and education costs. In certain cases, support has also gone towards easing small debts. This is short-term, emergency help — designed to lift families back onto their feet with dignity.

APPLICATIONS AND IMPACT

Over the last year, we have received applications from several Jamaats, including **Birmingham**, **Leicester**, **Hujjat**, **Hyderi**, and **Peterborough**.

- Number of Families Supported: 45
- Average Grant per Family: Up to £500 depending on need.

Behind every figure is a family that was able to keep their heating on, put food on the table, or ensure their children could continue with their education. These are not just numbers — they are lives touched and hardships eased through your generosity.

IMPROVING THE PROCESS

This year, we updated the application form to make it clearer and more thorough. The aim is simple:

- To help applicants explain their situation in detail, so they receive the right kind of support.
- To enable Jamaats to carry out proper due diligence and ensure funds are reaching those who are genuinely in need.
- To speed up the process and avoid delays by having all the information upfront.

Applications remain strictly confidential, but this new process gives Jamaats a fuller picture of what families are going through and allows them to respond more effectively.





POWERED BY SADAQAH

The Imam Ridha (a.s) Hardship Fund exists entirely because of the **Sadaqah** given by our community. Each contribution — small or large — directly helps a family facing hardship.

In Islam, Sadaqah is more than charity. It is a source of blessings, it protects against trials, and it brings joy to both the giver and the receiver. By donating through the CoEJ website, you are making sure that your contribution goes straight to those who need it most, across all our Jamaats.

PALLIATIVE CARE







EUROPEAN MADARIS DEPARTMENT

LEADERSHIP ENGAGEMENT

• One-to-one meetings with the leadership of all member Madaris have now taken place. These conversations helped build mutual understanding, introduce EMD's mission, and begin identifying strategic needs.

HOLY QUR'AN DISTRIBUTION INITIATIVE

- A generous donation of 2,000 copies of the Holy Qur'an (suitable for children aged 9+) was received in June 2025.
- ◆ 50% of these have already been dispatched to Madaris across the region.

Qur'an Teacher Training Course - Registration

Registration for the online Qur'an Teacher Training course (in collaboration with QARI) successfully completed in June 2025.

TEAM DEVELOPMENT

The EMD core team is beginning to take shape, with key roles currently being defined.

UPCOMING

MADRASAH LEADERSHIP CONFERENCE

A regional conference is tentatively being planned. The aim is to bring together madrasah leaders for consultation, networking and joint planning.

QUR'AN TEACHER TRAINING COURSE

Course delivery will commence in September 2025, offering structured support and upskilling for Qur'an teachers across member madaris.

COMMUNITY INSIGHT SURVEYS

- ❖ A series of surveys will be launched to gather meaningful input from
 - Madrasah leadership (operational data, needs, challenges, aspirations)
 - Teachers (experience, training needs, support)
 - * Parents and Students (perception of impact and value of madrasah education).

IN-PERSON MADARIS VISITS

A series of regional visits will take place between September 2025 and March 2026, enabling EMD to engage directly with institutions and build deeper relationships.












CAMP COEJ 2025

- Each day started with Jamaat salaah and Qur'anic reflections.
